[N] Note 2: In addition to the rate noted above, a capital surcharge of 30.0 cents per barrel will be applied to all deliveries originating from Main Pass 313. The surcharge will apply to the first 2,000,000 barrels accumulated beginning March 1, 2021 and will be removed once the required volume accumulation has been met.
