**Note 1:** Pursuant to Item No. 105 (ADDITIONAL CONTRACTS) in Carrier's Rules and Regulations Tariff L.P.S.C. No. [W] 25.5, the Firm Service Committed Rate shall be available only to Shippers (as defined in the Tariff) that have executed a Firm Service Revenue Deficiency/Commitment Agreement with Carrier pursuant to which such Shipper is allocated reserved capacity and commits to ship for transport, or pay a deficiency payment in lieu thereof, a minimum daily volume of 25,000 barrels per day for a contract term of not less than five years.

### Exceptions to Crescent Midstream, LLC's L.P.S.C. Tariff No. [W] 25.5 and reissues thereof:

Item No. 77

Shippers qualifying for the Firm Service Committed Rate herein shall be prioritized in the event monthly nominations are in excess of the maximum monthly volume capacity of the line segments between Main Pass 69A and the Chevron Empire Terminal and such Firm Service Shippers' committed minimum daily volume shall not be subject to apportionment, provided that the sum of the volumes of Firm Service Shippers shall not exceed 90% of the total available monthly capacity on the line segments. The remaining capacity will be apportioned in accordance with Item No. 77 of Carrier's LPSC Tariff No. [W] 25.5 and reissues thereof.
